# DIVISION VIRTUAL ORIENTATION ON THE ARAL SCHOOL READINESS AND RESPONSIVE AUDIT (ASRRA)

- Pursuant to Republic Act 12028, or the Academic Recovery and Accessible Learning Program Act, and DepEd Order No. 018, s. 2025, titled Implementing Guidelines of the ARAL Program, the Department of Education - Schools Division of Aklan shall conduct a Division Virtual Orientation on the ARAL School Readiness and Responsive Audit (ASRRA) on Monday, August 4, 2025, from 1:00 PM to 5:00 PM through MS Teams. The link shall be posted to the PSDS Chat Group.
- 2. The virtual orientation aims to:
  - a. Provide an overview of the ASRRA as a quality assurance mechanism to assess school-level readiness in delivering ARAL interventions;
  - Operationalize the conduct of ASRRA as prescribed under Section M.87 of DO 018, s. 2025; and
  - Submit Beginning of School Year (BOSY) ASRRA results in the link provided on or before the deadline.
- 3. The participants in the activity are the Public Schools District Supervisors, Principals, and Head Teacher In-Charge of the District, School Leaders of the Primary, Elementary, Secondary, and Integrated Schools in the Schools Division of Aklan. They may gather in a hall /room with strong internet connectivity.
- The expenses incurred for attendance to this activity shall be charged against local funds, subject to the usual accounting and auditing rules and regulations.
