The Civil Service Commission National Capital Region (CSC NCR) will conduct the Public Service Excellence Forum, with the theme Public Service Reimagined: Building Bridges to a Future-Ready Government, to be held in Pampanga on November 11-12, 2025.

The two-day forum is designed to empower public servants to embrace innovation, take calculated risks, and lead continuous improvement within their respective institutions. Participants will engage in thought-provoking discussions on key competencies and emerging challenges that impact the delivery of excellent public service.

A key highlight of the event is the recognition of regional and semi-final awardees of the 2025 Search for Outstanding Government Workers under the Honor Awards Program, as well as the Program to Institutionalize Meritocracy and Excellence in Human Resource Management awardees. The program will also feature the soft launch of the 2026 Search for Outstanding Government Workers.

Interested participants may coordinate directly with their respective CSC NCR field office on or before September 5, 2025.

Participation of learners and teachers from public and private schools shall be purely voluntary and will not hamper instructional time in compliance with the provisions of DepEd Order (DO) No. 012, s. 2025, titled Multi-Year Implementing Guidelines on the School Calendar and Activities and DO 9, s. 2005 titled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith and the policy on off-campus activities stated in DO 66, s. 2017.

This is also subject to the no-collection policy as stated in Section 3 of Republic Act No. 5546 also known as An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges and Universities (Ganzon Law), issued in DO 19, s. 2008, and reiterated in DepEd Memorandum No. 041, s. 2024.
