The announcement of top three (3) winners shall be made **on or before September 15, 2025.** The winning piece will be used as the official entry of the Office to the Regional Milk Dance Challenge Competition.
4. Prizes for the top 3 winners shall be the following:

First Place: ₱ 5,000.00 for the students and Certificate of Recognition for the School.

Second Place: ₱ 3,000.00 for the students and Certificate of Recognition for the School.

Third Place: ₱ 2,000.00 for the students and Certificate of Recognition for the School.


