1. Pursuant to Presidential Proclamation No. 242, s. 20211 titled Declaring the Period from September 5 to October 5 of Every Year as National Teachers' Month and Republic Act No. 10743 titled an Act Declaring the fifth Day of October of Every Year as the National Teachers' Day, this office conducts "*Hinampang 2025*", to give honor to all teaching, non-teaching and teaching-related personnel in the Schools Division of Aklan on October 4, 2025, at Numancia Sports and Cultural Center, Población, Numancia, Aklan.

2. This activity aims to:

- a. honor and celebrate the dedication and contributions of all DepEd personnel in Aklan;
- b. recognize the important roles of teachers as modern-day heroes;
- c. foster camaraderie, unity, and team spirit among educators and DepEd staff through sports and recreational activities;
- d. promote work and life balance, physical well-being, and strengthen relationships within the education community in a fun and engaging environment; and
- e. create a memorable and meaningful celebration for the 2025 World Teacher's Day.

3. The sports activities and fellowship night of "*Hinampang 2025*" are basketball for men, volleyball for men and women, Hip-hop dance presentation, choral presentation, and Zumba for all.

4. The participating teams of this one-day activity are DepEd Sports Units, which comprise Unit 1, Unit II, Unit III, Unit IV, Unit V, and Unit VI. Each unit may have team captains and muses to lead during the parade. The Public Schools District Supervisors are the unit managers.

5. The eligible players are the plantilla personnel of SDO Aklan and School Heads/School Administrators of Private Schools, while the participants for hip-hop dance and choral presentation are open to all personnel.

6. During the fellowship night, School Heads are encouraged to attend in semi-formal wear. The Hip-hop dance presenters are from the districts of Kalibo, Altavas, Batan, Malay, Libacao, Ibajay, and Tangalan. The Choral presentations will be coming from the districts of Lezo, Balete, Makato, Nabas, New Washington, Buruanga, and the Division Office. The Districts of Banga, Madalag, Malinao, and Numancia will give the Intermission Numbers.

7. Saturdays and Sundays of September and after-class hours shall be dedicated to the practice schedule of the participants in compliance with the no-disruption-of-classes of classes policy based on DO No. 09, s. 2005 titled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith.



VOLLEYBALL

1. Each team consists of 14 to 16 players, including 2 Liberos.
 - A. Set 1 - 6 regular players + 1 substitute + 1st Libero
 - B. Set 2 - 6 regular players + 1 substitute + 2nd Libero
Note: Set 1 players are not allowed to play in Set 2.
 - C. Set 3 (If possible) The team can select their best players to play.
2. Tournament Format. Single Elimination for 8 participating teams




3. Each player's jersey must have the same color and display a unique number.

BASKETBALL

1. A minimum of twelve (12) and a maximum of sixteen (16) players in every team. Five (5) players play for five minutes without substitution in a period.
2. The match was determined through a draw lots conducted during the coordination meeting.
3. The team captain must ensure that the lineup of the team has a playing time.
4. All teams must wear basketball jerseys during their games. Each jersey must have the same color, and it must have numbers. Basketball shoes must be worn. All jewelry must be removed. Necklaces, earrings, and watches cannot be worn during the game.
5. Players must fully understand the FIBA tournament rules and regulations.

Tournament Format

1. Single elimination in each bracket
2. The winner in each bracket will play for the championship



SKILLS CHALLENGE

1. Four players on each team
2. Must make a basket in each designated spot
3. The shortest time to finish the challenge will be the champion

HIP-HOP DANCE AND CHORAL PRESENTATION

Hip-Hop Dance Presentation

Guidelines

- Each group must consist of a minimum of 10 and a maximum of 15 members.
- Time limit: 4-6 minutes, including entrance and exit.
- Props may be used but must be safe and manageable.
- Costumes should be decent, appropriate, and aligned with the celebration.
- Vulgarity, offensive gestures, or inappropriate lyrics are strictly prohibited.
- Music must be pre-edited and submitted before the performance.

Choral Presentation

Guidelines

- Each choir must have at least 10 members, a maximum of 20 members
- Time limit: 5–7 minutes (including entrance/exit).
- Groups must perform at least 2 pieces of Aklanon folk songs.
- Uniform attire and props are optional.
- No pre-recorded voices allowed; only live accompaniment or a cappella.
