COMPOSITION OF THE WESTERN VISAYAS REGIONAL SPORTS BOARD

1. Pursuant to the mandate of the Department of Education to strengthen the implementation of the school sports program to promote physical fitness, sportsmanship, and holistic development among learners and to ensure effective management and governance of the Western Visayas Regional Athletic Association (WVRAA), the **Western Visayas Regional Sports Board (WV-RSB)** is hereby constituted.

2. The WV-RSB shall be composed of the following:

Chairperson: Regional Director

Vice-Chairperson: Assistant Regional Director

Members: Schools Division Superintendents

Honorary Members: Provincial Governors and City Mayors

Ex-Officio Members: Regional Sports Officer
Division Sports Officers

Secretariat: Education Program Supervisor from the Policy, Planning and Research Division
Technical Assistant II – Learner Rights Protection /
Project Development Officer II - Learner Rights Protection

3. The WV-RSB shall have the following functions:

- a. Formulate policies and guidelines governing the conduct of the WVRAA Meet and other regional sports activities and the participation to the *Palarong Pambansa*;
- b. Provide technical and administrative support to Division delegations;
- c. Ensure the welfare, safety, and protection of athletes and sports officials;
- d. Recommend strategies for talent identification, training, and development of student-athletes;
- e. Strengthen partnerships with the Local Government Units and stakeholders in support of the sports development program of the Region; and
- f. Monitor and evaluate the conduct of sports activities in alignment with the national directives.
