1. This Office announces the changes on the schedule and venue of the Division Training on Campus Journalism dubbed as Vice Governor Journalism Cup from November 8-9, 2025 to November 15-16, 2025 for both Eastern and Western participants. Elementary level will be at Mayor Teodoro F. Calizo, Sr. Memorial Civic Center and Mayor Miguel Calizo Multi-Purpose Building, Poblacion, Balete, Aklan and the Secondary level will be at Lezo Integrated School, Lezo, Aklan.

2. In addition, the participants can be both from public and private schools. For the elementary level there must be at least 5 campus journalists per central school and at least of 3 campus journalists per non-central school. However, for secondary level, there must be at least 5 campus journalist per school. In case that there are schools without participants, the slots can be given to the schools with interested participants but not to exceed the number of slots per District. Special program in Journalism schools may send at least 10 campus journalist per school. There is no limit for the number of school paper advisers and coaches.

3. All other provisions of this Memorandum will remain in effect.


DIVISION TRAINING ON CAMPUS JOURNALISM

1. This Office in partnership with the Office of the Vice Governor, Hon. Dexter M. Calizo, announces the Division Training on Campus Journalism dubbed as Vice Governor Journalism Cup on November 8-9, 2025, at Mayor Teodoro F. Calizo Sr. Memorial Civic Center and Mayor Miguel Calizo Multi-Purpose Building Poblacion, Balete, Aklan for Eastern Aklan and on November 15-16, 2025, at Lezo Integrated School, Lezo, Aklan (Elementary) and Malinao Plaza Covered Court, Malinao, Aklan (Secondary).
2. The conduct of a two-day Campus Journalism Training aims to equip the participants the basic competencies in campus journalism.
3. Participants in this training are the school heads of the schools offering Special Programs in Journalism (SPJ), School Paper Advisers (SPA), coaches, and campus journalist of public elementary and secondary schools.
4. It is understood that in the conduct of this activity, there shall be no discrimination on account of age, school, gender, civil status, disability, religion, or other similar factors/personal circumstances that run to the principles of equal opportunity.
5. The participants and training team members are entitled to Service Credits in accordance with DepEd Order No. 53, s. 2003 titled: Updated Guidelines on the Grant of Vacation Service Credits to teachers. On the other hand, non-teaching personnel shall be provided with Compensatory Time Credits (CTC) for their services rendered as per Civil Service Commission (CSC) and Department of Budget and management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.

6. There shall be No Registration Fee. The traveling expenses, per diems, and other expenses relative to the conduct of this activity shall be charged to local school funds, Special Education Fund, and/or other eligible fund sources subject to the usual government accounting and auditing rules and regulations.

7. Immediate dissemination of this Memorandum and compliance is desired.
