#### REQUESTING LOCAL GOVERNMENT UNITS, CONCERNED AGENCY REGIONAL OFFICES, AND PRIVATE SECTOR ORGANIZATIONS IN WESTERN VISAYAS TO SUPPORT/PARTICIPATE THE NATIONAL VEGETABLE CONGRESS 2025

**WHEREAS**, the Province of Iloilo will host the 2025 National Vegetable Congress on November 5-7, 2025 at the Tamasak Arena, Barotac Nuevo, Iloilo;

**WHEREAS**, the three-day national event is being organized by the POPA Agriculture Cooperative in collaboration with the Local Government Unit of Barotac Nuevo, the Iloilo Provincial Government, the Regional Agricultural and Fishery Council (RAFC) VI, and regional line agencies such as DA Region VI;

**WHEREAS**, the event, with the theme, *Innovative. Resilient. Market-Ready: Revitalizing the Vegetable Industry for a Food-Secure Bagong Pilipinas*, aims to promote market-oriented and climate-resilient vegetable farming, showcase technologies and innovations in production, mechanization, and postharvest systems, and craft a multi-sectoral declaration to advance the National Vegetable Roadmap;

**WHEREAS**, the event, which is expected to gather over 1,500 participants from across the country, particularly farmers, cooperatives, agripreneurs, traders, government agencies, LGUs, researchers, industry leaders, and private sector partners, will feature plenary talks, knowledge sessions, exhibitions, market linkage sessions, regional action planning workshop, and farm tours in Ina Farmers Learning Site and Agri-Farm (in Barotac Nuevo), Damires Hills Farm (in Janiway), and Orchard Valley (in Pavia);

**WHEREAS**, POPA Agriculture Cooperative, in its letter dated August 27, requested for endorsement of the event to ensure widespread participation and impact of the national event;

**WHEREAS**, during its 3<sup>rd</sup> Quarter meeting last September 17, 2025, EDC VI endorses the event to RDC VI given its contribution to the development of the agriculture sector of Western Visayas and its alignment with the strategies of the Western Visayas Regional Development Plan (RDP) 2023-2028 Midterm Update on modernizing the agricultural sector by promoting innovation and market readiness, strengthening food security through sustainable and resilient farming, and enhancing the knowledge and farm income of vegetable farmers;
