- 6. All athletes must be properly supervised by their coaches for the whole duration of the event. However, in the absence of the official coach, the Assistant coach or the other coach/assistant coach in their same unit/district may take over.
- 7. Coaches are required to submit the signed waiver form by the athlete's parents/guardians to the Tournament Director of Athletics, **Attn. John Michael T. Ibo**.
- 8. All Unit heads and coaches are requested to ensure that their athletes are aware, prepared, and have submitted the required waiver forms before departure. Strict adherence to safety protocols and proper conduct is expected throughout the event.
- 9. Technical officials, working committees and other participants shall be granted service credits according to the provisions of DepEd Order No.53, s. 2003 titled "Updated Guidelines on Grant of Vacation Service Credits to Teachers" and other existing Department of Budget and Management (DBM)/Civil Service Commission (CSC) laws.
- 10. Expenses incurred by athletes, coaches, assistant coaches, chaperons, and DepEd officials in the attendance and conduct of these activities are chargeable against local funds, subject to the usual accounting and auditing rules and regulations.

11. Immediate and wide dissemination of this Memorandum is highly enjoined.
