- 1. This memorandum serves to inform all concerned that an **In-Service Training (INSET) for Alternative Learning System (ALS) Teachers** will be conducted on December 18-21, 2025, at Adee's Catering, Capitol Site, Kalibo, Aklan.
- 2. The activity aims to strengthen and enhance the instructional competencies of ALS teachers through focused capacity-building sessions on the mastery and application of the 4A's Teaching Approach, the integration of Higher Order Thinking Skills (HOTS) in ALS instruction, effective lesson planning integrating 4A's and HOTS, and the utilization of appropriate Alternative Delivery Modes (ADM) responsive to the diverse needs of ALS learners.
- 3. Expected participants include the ALS Education Program Supervisor (EPS), Education Program Specialists, teachers, designated ALS resource speakers, and facilitators. The training will involve discussions, workshops, and collaborative activities aligned with the stated focus areas.
- 4. Participants are advised to bring their ALS learning materials, writing materials, laptops, and extension wires to ensure active participation during the sessions.
- 5. School Heads and Teacher-Participants shall make necessary arrangement of class schedules adherence to DepEd Order No. 9, s. 2005 on instituting measures to increase engage-time-on task and shall not cause any class disruptions.
