

Participants will audit courses in the host university's School or Department of Education and thus will be part of the general university community. The program will include opportunities to observe and co-teach with U.S. teachers in a U.S. school near the host university. The scholarship includes academic program fees, monthly maintenance allowance, technology allowance, health and accident insurance, roundtrip international airfare, and excess baggage allowance.
