

1. Pursuant to Presidential Proclamation No. 683, s. 1991 which declares the month of February as the National Arts Month and in relation to the advocacy of the National Commission for Culture and the Arts (NCCA), this Office supports and encourages the celebration of this month-long activity.
2. The National Arts Month Celebration 2026 aims to highlight the skills and talents of learners through engaging exhibits and artistic performances to further bolster students' confidence and refine their presentation skills, emphasizing the integral role of art in community life and its significant contribution to fostering national pride.
3. In view of this, the following suggested activities may be undertaken by the SDOs:
 - a. organization of creative activities (e.g. music, dance, theater performances, local film screening, or visual arts exhibits, museum visits or local sites); and
 - b. display of National Arts Month promotional materials in the division offices and school premises (materials will be posted at the NCCA website).
4. The conduct of these activities shall adhere to the protection of instructional time policy pursuant to DepEd Order No. 09, s. 2005 titled Instituting Measures to Increase Engaged-Time-on-Tasks and Ensuring Compliance Therewith.
