On the other hand, non-teacher personnel shall be provided with Compensatory Time Off (CTO) for their services rendered during weekends and holidays as per Civil Service Commissions (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.
5. Travel and other expenses relative to this activity may be charged against local funds subject to the usual accounting and auditing rules and regulations.


