

2. The decision to postpone is due to the significant impact of Typhoons Tino and Uwan, which have caused substantial damage to properties and infrastructure in the area. Our primary concern is the safety and well-being of all prospective training staff and participants, as well as ensuring the venue and surrounding areas are fully secure and operational.
3. All arrangements, including travel and accommodations made for the aforementioned dates, should be cancelled or put on hold pending the release of the new schedule.
