**RESKILLING AND UPSKILLING OF MEDICAL OFFICERS AND
TOURNAMENT OFFICIALS ON THE PREVENTION OF
SPORTS-RELATED INJURIES**

To: Schools Division Superintendents
All Others Concerned

1. In the conduct of any sporting event, athletes are inevitably exposed to varying degrees of physical engagement that place them at risk of acquiring sports-related injuries. These risks are heightened in competitive sports environments where intensity, endurance, and physical contact are integral to performance. As such, the presence of competent medical personnel and well-informed tournament officials is essential to ensure immediate response, proper injury management, and the overall safety and well-being of athletes.

2. In view of this, and in support of the Department's commitment to learner safety, athlete welfare, and the promotion of a safe and healthy sporting environment, this Office, through the Education Support Services Division – Health and Nutrition Unit, in collaboration with the Schools Division of Aklan, will conduct the **Reskilling and Upskilling of Medical Officers and Tournament Officials on the Prevention of Sports-Related Injuries** on **March 3 - 6, 2026** in Aklan. The specific venue will be announced in a separate Memorandum.

3. The activity has the following objectives:

- a. Enhance the knowledge and competencies of Medical Officers and Tournament Officials on the prevention, early recognition, and management of sports-related injuries.
- b. Strengthen preparedness and response mechanisms during trainings and competitions particularly in combative sports.
- c. Promote standardized protocols on injury prevention and athlete safety in sporting events.
- d. Conduct accreditation of tournament officials for weightlifting to manage the regional sporting event.

The Schools Division Offices shall ensure that the classes of teaching personnel involved in the conduct of this activity are not disrupted through the employment of appropriate learning delivery modality or a substitute teacher who will take over the classes in compliance with DepEd Order No. 9, s. 2015 titled *Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith* and DepEd Order No. 012, s. 2025 titled *Multi-Year Implementing Guidelines on the School Calendar and Activities* while the office operations of the non-teaching personnel should be not be hampered.

The food and accommodation of the participants are chargeable against the downloaded program support fund (PSF) to the host Division, while their travel and other incidental expenses are chargeable against their local/MOOE funds subject to the usual accounting and auditing rules and regulations.
