1. This Office, in collaboration with the Schools Division of Passi City and the Local Government Unit (LGU) of Passi City, will conduct an **Interfacing of Regional and Division Technical Working Groups (TWGs) for the Alignment and Finalization of Workplans for the 2026 WVRAA Meet and Ocular Inspection of the Playing Venues on February 18 - 19, 2026** at the **Schools Division of Passi City**.
2. The activities aim to achieve the following:
