My mother has been confined at [Name of Hospital] since February 13, 2026. She is currently admitted to the Intensive Care Unit (ICU) battling multiple severe health conditions. Her diagnoses include Chronic Kidney Disease (Category 3), Diabetes Type 2, Severe Pneumonia, Bilateral Pleural Effusion (fluid in both lungs), Hypoalbuminuria, and critically low potassium levels. These conditions have been further complicated by heart failure.


