

1. In preparation for the conduct of the **2026 Western Visayas Regional Athletic Association (WVRAA) Meet**, this Office hereby adopts the **Established Rules and Ground Rules** for all sporting events to ensure uniformity, fairness, and orderly implementation of the competition.
2. These guidelines are based on the existing policies of the Department of Education (DepEd) and rules of each respective sports associations, and duly approved through Resolution No. 03 by the Western Visayas Regional Sports Board (WV-RSB) during the 3rd Western Visayas Regional Sports Board meeting held at the City of Passi Arena on February 26, 2026.
3. The rules shall serve as the official reference in the conduct of all games and related activities and shall be strictly observed by all participating delegations, coaches, assistant coaches, athletes, and tournament officials.
4. All Tournament Directors are directed to thoroughly orient their respective coaches, assistant coaches, chaperones and delegation heads on the adopted rules during the Solidarity Meeting and Refresher Course on March 16, 2026 prior the start of the competition.
