Now in its 7th year, IMPACT continues its mission to challenge and inspire future scientists through a friendly yet rigorous academic competition that brings together outstanding high school students from across the country.

IMPACT goes beyond a traditional quiz bee by offering participants a platform to push their limits, strengthen their appreciation of the sciences, and apply their knowledge under pressure. The competition covers a wide range of topics, including Algebra, Geometry, Trigonometry, Statistics, Classical Mechanics, Electromagnetism, Thermodynamics, Optics, and Waves.

The competition is open to all bona fide junior and senior high school students.
