On the other hand, non-teacher personnel shall be provided with Compensatory Time Off (CTO) for their services rendered during weekends and holidays as per Civil Service Commissions (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.
5. Travel and other expenses of the DepEd personnel and learners relative to this activity may be charged against School MOOE/local funds subject to the usual accounting and auditing rules and regulations. The first meal shall be AM Snacks of Day 1, and PM Snacks as the last meal of Day 2.

**PARENTAL CONSENT AND WAIVER FORM**

I understand that the Bureau of Learner Support Services-Youth Formation Division (BLSS-YFD) of the Department of Education (DepEd) shall implement the minimum public health standards set by the government to minimize the risk of the spread of any communicable disease, but it cannot guarantee that my child will not become infected.
