In accordance with the DepEd Order No. 88, s. 2010 titled Revised Manual of Regulations for Private Schools, and consistent with the Quality Management System's mandate for continuous improvement of processes and service delivery, this Office will conduct a virtual **Technical Assistance on the Profiling of Private Schools in Preparation for the Transition to Online Document Submission through the Quality Assurance Division Regulatory Information System (QADRIS)** on **April 21, 2026**, Tuesday, 1:00 P.M., via MS Teams. 2. The profiling activity aims to establish an updated and centralized database of private schools to ensure the efficient processing, monitoring, and tracking of regulatory applications under the QADRIS online system.
3. The participants for the activity are two (2) representatives from each private school, 1 Administrator/Principal/Director and 1 teacher/staff).
4. The attendance of all private schools shall be strictly monitored.
