1. Republic Act No. 6722, which was signed by President Corazon Aquino on May 29, 1989, also known as Aklan Day, declares every 25th day of April as the founding anniversary of the province of Aklan, Philippines.
2. In line with this, the DepEd Aklan will be conducting the DepEd Night on April 27, 2026, 7:00 PM at the Godofredo P. Ramos Grounds, Capitol, Estancia, Kalibo, Aklan.
3. This activity aims to:
 - a. commemorate the founding anniversary of the province of Aklan from its mother province, Capiz;
 - b. showcase the talents and skills of the students, teaching and non-teaching personnel of the Schools Division of Aklan; and,
 - c. create a memorable and meaningful celebration of Aklan Day.
4. There will be a set of presentations from all over Aklan.
5. School Heads, Public Schools District Supervisors, Principals, and Head Teachers in charge of the District are encouraged to attend and witness the presentations.
6. The participants and attendees are entitled to a Service Credits for their services rendered but not to exceed 15 days per year in accordance with DepEd Order No. 53, s. 2003, titled: Updated Guidelines on the Grant of Vacation Service Credits to teachers. On the other hand, non-teaching personnel shall be provided with Compensatory Time Off (CTO) for their services rendered during weekends and holidays as per Civil Service
