1. This Office in partnership with the Komisyon sa Wikang Filipino will conduct a hybrid consultative conference about the Akeanon Orthography on May 25-26, 2026 at Numancia Integrated School.
2. The conference aims to review and finalize the Akeanon Orthography and translate in Filipino to be used by the Aklanon learners of the Key Stage 1.
3. The participants in this consultative conference are the select writers of Akeanon Orthography, Translators in Filipino, layout artist, Division Coordinators of Mother Tongue, Reading (Elementary Level), Filipino (Elementary Level), and EPS In-charge of Filipino/Mother Tongue.
4. **Teacher participants participation are purely on voluntary bases only since it falls to summer vacation of teachers.**
5. Traveling and other incidental expenses will be charged to local funds subject to the usual government accounting and auditing rules and regulations.
6. The participants are entitled to Service Credits for their services rendered in accordance with DepEd Order No. 53, s. 2003 titled: Updated Guidelines on the Grant of Vacation Service Credits to teachers. On the other hand, non-teaching personnel shall be provided with Compensatory Time Credits (CTC) for their services rendered during weekend and holidays as per Civil Service Commission (CSC) and Department of Budget and management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for


