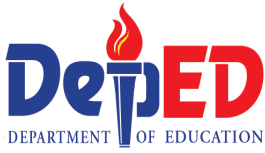

	<p><b>Guidelines for Interested Bidders:</b></p> <ol style="list-style-type: none"><li>1. Interested bidders are required to submit their Letter of Intent (LOI), clearly specifying the lot they intend to participate in, via email to <b>sdoaklan.bac@deped.gov.ph</b> prior to the deadline for the submission and opening of bids. For complete details, please refer to <b>Notice of Postponement No. 2026-05-002</b>, issued on May 13, 2026, and posted on the PhilGEPS and the official DepEd Aklan website.</li><li>2. Upon receipt and validation of the LOI, the BAC Secretariat shall issue a Purchase Slip. Bidders are advised to await the issuance of the Purchase Slip before proceeding with any bank deposit.</li><li>3. Once the Purchase Slip has been received, payment for the bidding documents may be deposited to the designated bank account. The deposit slip must thereafter be emailed to <b>sdoaklan.bac@deped.gov.ph</b> for proper recording and verification.</li><li>4. All submissions and transactions must be accomplished in a timely manner to allow sufficient time for verification and confirmation by the BAC Secretariat and the Cash Unit.</li><li>5. The Cash Unit of DepEd SDO Aklan shall verify the crediting of payments to the Procuring Entity's bank account prior to the issuance of the Official Receipt.</li><li>6.
