**MOBILIZATION OF SUPPORT TO AFFECTED DIVISIONS
BY MAGNITUDE 7.8 EARTHQUAKE IN MINDANAO**

To: OIC-Assistant Regional Director
Schools Division Superintendents
Chiefs, Functional Division and Unit Heads
All Others Concerned

1. In view of the recent Magnitude 7.8 earthquake that struck Maasim, Sarangani Province and other parts of Mindanao resulting in damages to school infrastructure and non-infrastructure facilities and affecting learners and personnel, this Office hereby calls for the mobilization of support to the heavily affected Schools Division Offices.
2. Relative thereto, the Regional Office and Schools Division Offices (SDO) are enjoined to extend assistance through the provision of **immediate relief** and assistance.
3. Likewise, Regional and Division Disaster Risk Reduction and Management (DRRM) Coordinators shall assist in the assessment and validation of damaged schools through the conduct of Rapid Assessment of Damages Report (RADaR) and Post-Disaster Needs Assessment (PDNA) and the conduct of Psychological First Aid (PFA) if required by the Disaster Risk Reduction and Management Service.
4. Schools Division Offices are assigned to provide support and assistance to the following affected divisions on or before **June 25, 2026** through the identified contact person:
