**TIMELINE AND CONDUCT OF THE ELECTION OF THE NEW SET OF SCHOOL
GOVERNANCE COUNCIL (SGC) OFFICERS FOR
SCHOOL YEARS 2026–2027 TO 2028–2029**

1. In reference to DepEd Order No. 026, s. 2022, otherwise known as the **Implementing Guidelines on the Establishment of School Governance Council (SGC)** and Regional Memorandum No. 675, S. 2026 titled **Timeline and Conduct of the Election of the New Set of School Governance Council (SGC) Officers for School Years 2026–2027 to 2028–2029**, this Office announces the conduct of the election of the new set of School Governance Council (SGC) Officers.
2. The election aims to ensure the continuous implementation of shared governance principles and strengthen stakeholder participation in school planning, decision-making, and implementation of programs, projects, and activities.
3. In accordance with Section J (Tenure) of DepEd Order No. 026, s. 2022, all SGC officers shall serve a term of three (3) School Years. Accordingly, the officers to be elected through this process shall serve for School Years 2026–2027, 2027–2028, and 2028–2029.
4. The election shall cover the following positions:
 - a. Elected Co-Chairperson – to be elected from among the external stakeholder voting members of the SGC; and
 - b. Secretary – to be elected from among the voting members of the SGC.
5. The basic organizational structure of the School Governance Council is presented below.

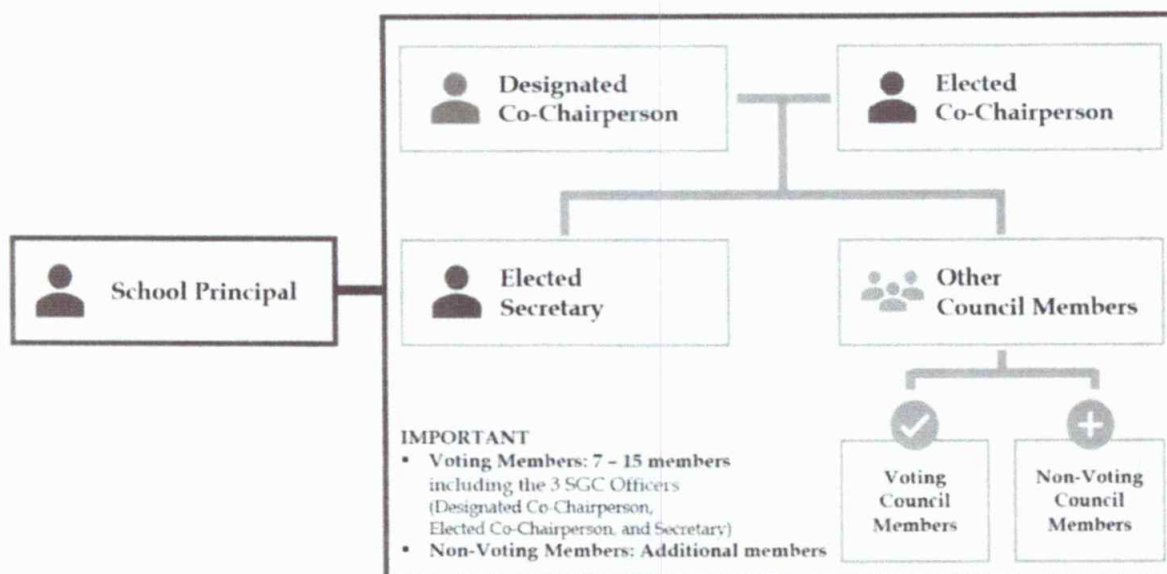
