6. Travel and other expenses incurred of all participants relative to this activity may be charged against local funds subject to the usual accounting and auditing rules and regulations.

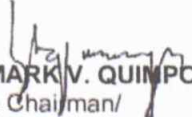

**SUBJECT: 2026 SIMULTANEOUS SCHOOL-BASED LEADERSHIP TRAINING AND
ADVANCEMENT CAMP**

1. Pursuant to DO No. 009 S. 2026, titled "Guidelines on the Implementation of the Three (3) Term School Calendar in Basic Education", Annex B - Three-Term School Calendar in Basic Education for School Year (SY) 2026-2027, September 2-15 is End-of-Term Block for the 1st Term.
2. In this regard, the Aklan Council, Boy Scouts of the Philippines urged the Schools/Districts to conduct the 2026 Simultaneous School-Based Leadership Training and Advancement Camp on September 3-5, 2026.
3. The purpose of this training/activities are the following:
 - a. To enhance the leadership skills through Leadership in Scouting, the "Patrol System".
 - b. To provide scouts an opportunity to camp and learn various scouting skills.
 - c. To equip scouts to meet outdoor requirements in the Advancement Ladder.
4. Scout participants must be:
 - a. Currently registered with the BSP
 - b. Physically fit and with parents' permit
 - c. Must be;
 - KID Scout- 4-6 years old
 - KAB Scout- 6-9 years old
 - Boy Scout- 9-12 years old
 - Senior Scout- 12-18 years old
5. Scout and Scout Leaders are encouraged to wear BSP type A or type B scout uniform during the activity.
6. Suggested budget per participant:

a. Membership fee	P 50.00
b. Activity fee	P 170.00
c. Meals:	
i. 2 breakfast x P50.00	= P 100.00
ii. 2 lunch x P60.00	= P 120.00
iii. 1 dinner x P60.00	= P 60.00
iv. Wednesday night packed dinner	<u>P 280.00</u>
	<u>P 500.00</u>
