**RESOLUTION NO. 727-2026**

**“A RESOLUTION URGENTLY REQUESTING THE AKLAN PROVINCIAL POLICE OFFICE (APPO), IN COORDINATION WITH THE DEPARTMENT OF EDUCATION (DEPED) – SCHOOLS DIVISION OF AKLAN, PRIVATE AND GOVERNMENT SCHOOL ADMINISTRATORS, AND LOCAL GOVERNMENT UNITS, TO IMMEDIATELY INCREASE POLICE VISIBILITY AND IMPLEMENT STRATEGIC SECURITY PATROLS IN ALL PUBLIC AND PRIVATE SCHOOLS IN THE PROVINCE OF AKLAN TO ENSURE THE SAFETY OF STUDENTS, TEACHERS, AND SCHOOL PERSONNEL”**

**WHEREAS**, the maintenance of peace and order and the protection of life, liberty and property are duties of government and essential to the promotion of the general welfare, as provided by Section 5, Article II of the 1987 Constitution of the Republic of the Philippines;

**WHEREAS**, the recent shooting incident at San Jose National High School, Tacloban City and the stabbing incident in Cavite National High School, Cavite City and Bethel Academy in General Trias, Cavite, which resulted in multiple fatalities and injuries, had underscored the potential vulnerability of schools to acts of violence and the need for urgent preventive measures in all local jurisdictions;

**WHEREAS**, while the tragic incident occurred outside the territorial jurisdiction of the Province of Aklan, it serves as a serious warning and calls for proactive measures to enhance the safety and security of students, teachers, school personnel, and visitors in all educational institutions within the Province;

**WHEREAS**, schools are constitutionally protected and community-valued safe spaces for learning and development that must be safeguarded from criminality, violence, and other threats that disrupt education and endanger lives;

**WHEREAS**, the visible and active presence of uniformed police personnel and coordinated security patrols deters crime, enables rapid emergency response, and reassures parents, students, and school staff;

**WHEREAS**, effective school security requires multi-sectoral coordination among the Aklan Provincial Police Office (APPO), the Department of Education (DepEd) - Schools Division of Aklan, private school administrators, provincial and municipal/local government units (LGUs), barangay authorities, and other relevant stakeholders;

**NOW, THEREFORE**, Be It **RESOLVED**, As It Is Hereby **RESOLVED**, By The Sangguniang Panlalawigan Of The Province Of Aklan In Session Duly Assembled: TO REQUEST THE AKLAN PROVINCIAL POLICE OFFICE (APPO), IN COORDINATION WITH THE DEPARTMENT OF EDUCATION (DEPED) – SCHOOLS DIVISION OF AKLAN, PRIVATE AND GOVERNMENT SCHOOL ADMINISTRATORS, AND LOCAL GOVERNMENT UNITS, TO IMMEDIATELY INCREASE POLICE VISIBILITY AND IMPLEMENT STRATEGIC SECURITY PATROLS IN ALL PUBLIC AND PRIVATE SCHOOLS IN THE PROVINCE OF AKLAN TO ENSURE THE SAFETY OF STUDENTS, TEACHERS, AND SCHOOL PERSONNEL.

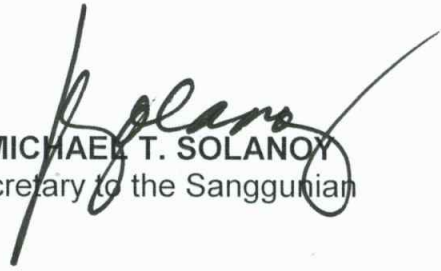
**RESOLVED, FURTHER**, that the APPO be requested to institutionalize a Provincial School Security Coordination Mechanism (PSSCM) composed of representatives from: APPO, DepEd Schools Division of Aklan, Provincial/Municipal LGUs, the Provincial Disaster Risk Reduction and Management Office (PDRRMO), the Provincial Social Welfare and Development Office (PSWDO), private school associations, and Liga ng mga Barangay President, to meet regularly (at least monthly for the first six months) to coordinate implementation, monitor security incidents, and harmonize responses and resource-sharing.

**RESOLVED, FURTHERMORE**, that DepEd Schools Division of Aklan and private school administrators are requested to provide updated school maps, schedules, enrollment figures, designate a School Safety Focal Person per school, and align internal protocols with APPO and LGU procedures.

**RESOLVED, FINALLY**, that the APPO, DepEd Schools Division of Aklan, and all Municipal Mayors, Private Schools be furnished with copies of this Resolution for their immediate action.
