On the other hand, Non-Teaching personnel shall be granted with Compensatory Overtime Credits (COC) for their services rendered during weekends and holidays as per Civil Service Commissions (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.

4. **TABUENA**, Chester I.

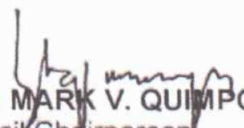
