1. Attached is the Council Information Circular No. 14, s. 2026 from the Boy Scouts of the Philippines – Aklan Council dated August 7, 2026 regarding the **Linggo ng Kabataan 2026 “Tree Planting Activity”**, August 15, 2026 at Camanci Norte, Numancia, Aklan.
2. Teachers/Adult Leader participants are entitled to Service Credits for their services rendered during weekends and holidays but not to exceed 30 days per year in accordance with DO No. 13, s. 2024 titled: “Revised Guidelines on the Grant of Vacation Service Credits to Teachers. On the other hand, Non-Teaching personnel shall be granted with Compensatory Overtime Credits (COC) on their services rendered during weekends and holidays as per Civil Service Commissions (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.
3. The **District Learner Rights and Protection** of Numancia shall set-up “LRP Help Desk” or Learner Rights and Protection – Help Desk and designate a personnel on-duty while the activity is on-going.
4. The learner participant must accomplish Learner Consent Form Parental Consent and Waiver Form prior to the conduct of the activity and must be collected by the event organizer.



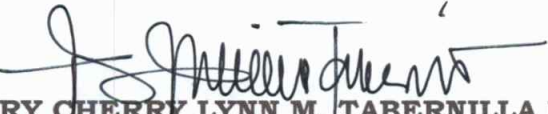

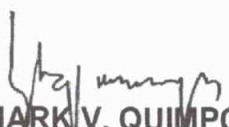
