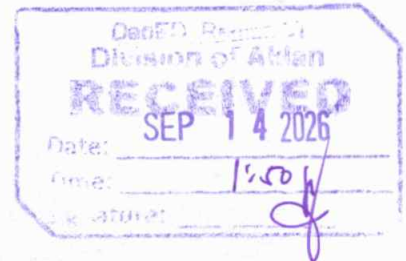

We are writing to you today with heavy hearts to humbly appeal for voluntary medical assistance for one of our cherished Grade VI learners, Ashley Quillano Lauz. Ashley is the daughter of Mrs. Angie Q. Lauz, a dedicated Teacher VI at Jose Feliciano Meñez Memorial National High School.

As a young student practicing for a throwing event on August 11, 2026, Ashley suffered a tragic accident when she was accidentally hit by a javelin. She sustained a severe traumatic brain injury, open depressed skull fracture, cerebral contusion, dermal tear, and left frontal injury. Following her initial prolonged confinement, she experienced post-operative complications (wound dehiscence) that required a readmission and subsequent major surgeries, including wound debridement and mesh cranioplasty.

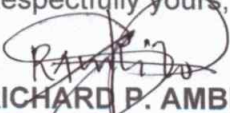
The family has been overwhelmed not only by the emotional toll of this tragedy but also by the staggering financial burden. Between the heavy hospital bills and the extensive professional and surgeon fees spanning both admissions, the expenses have grown beyond what they can bear.

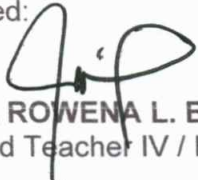
