2026 WORLD SUICIDE PREVENTION DAY

1. In reference to Division Memorandum No. 444, s. 2026 dated August 3, 2026 regarding **Learner Support Observances for SY 2026-2027, September 10, 2026** is hereby declared as **World Suicide Prevention Day**, with the theme: **“Changing the Narrative on Suicide”**.
2. The theme underscores the importance of transforming societal attitudes surrounding suicide by moving away from silence, stigma, and discrimination, and instead fostering empathy, openness, and support.
3. Schools may conduct activities such as Wall of Hope/Hope Board, mental health awareness sessions, wellness campaigns, peer support activities, IEC campaigns on suicide prevention and other classroom-based activities.
4. Participation in the activity shall subject to DepEd Order No. 009, s. 2026, entitled *“Guidelines on the Implementation of the Three-Term School Calendar in Basic Education”*, and other applicable DepEd policies. Considering that the activity falls within the Term 1 End-of-Term Block, schools are advised to conduct suicide prevention activity within the month of **September 2026**.
5. School mental health coordinators, in accordance with concerned school personnel, shall facilitate the activities and ensure appropriate support and referral for learners or personnel who may need assistance.
6. Schools shall document their activities and submit a soft copy of brief accomplishment report through this link <https://bit.ly/SDO-Aklan-2026-World-Suicide-Prevention-Day> on or before **September 30, 2026**.
7. All expenses related to the conduct of this activity may be charged against MOOE/local funds, all subject to the usual accounting and auditing rules and regulations.

The Department of Education, through the Bureau of Learner Support Services (BLSS), issues the following guidance to Regional Offices (ROs), Schools Division Offices (SDOs), and schools, pursuant to Section V.B. Co-Curricular Activities and Legislated Celebrations of **DepEd Order (DO) No. 9, s. 2026**, titled *Guidelines on the Implementation of the Three-Term School Calendar in Basic Education*:

1. Attached as **Annex A** is the list of recommended learner support observances for SY 2026-2027. All ROs, SDOs, and teaching and non-teaching personnel are encouraged to support the commemoration of these observances through information dissemination and conduct of related activities.
2. Consistent with DO 9, s. 2026, commemoration of learner support observances in schools during the instructional block shall primarily be through integration in regular teaching and learning process. Additionally, observances may be incorporated as part of:
 - a. After-class activities
 - b. End-of-term block activities
 - c. Pep talks or similar activities during flag ceremonies
 - d. Printed IEC materials and behavioral nudges (which can be kept throughout the school year)
3. BLSS enjoins teaching and other non-teaching personnel to utilize the compendium of resources and references accessible through this link <https://bit.ly/schoolhealth2627>
4. Subsequent advisories may be issued, as necessary, to provide further details on learner-support observances (e.g. annual theme, key messages, other materials or references).
5. All expenses related to the conduct of these observances may be charged against the Learner Support Program Funds or local funds, subject to usual accounting and auditing rules and regulations.
