Teachers/Adult Leaders and Members of the Panel of the Board of Review are entitled to Service Credits for their services rendered during weekends and holidays but not to exceed 30 days per year in accordance with DO No. 13, s. 2024 titled: “Revised Guidelines on the Grant of Vacation Service Credits to Teachers. On the other hand, Non-Teaching personnel shall be granted with Compensatory Overtime Credits (COC) on their services rendered during weekends and holidays as per Civil Service Commissions (CSC) and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration for Overtime Service Rendered.
3. Travel and other expenses relative to this activity may be charged against local funds subject to the usual accounting and auditing rules and regulations.

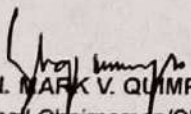
